Hostel/Canteen/Transport facility

General :

Foreign Students:

Colleges are required to inform in advance in respect of Students who are from foreign Countries studying in India and desirous of undergoing Project/In Plant Training in ITI Limited. The details may include Passport No, Country of origin, Place and Country of Birth, Validity of Passport, VISA details, Contact details. Such students are also required to submit a copy of the Passport and VISA. The students may also be advised to carry original Passport at the time of Visit.

Payment of Fees:

The students may either draw a DD in favour of **ITI Limited Bangalore** towards the Training fee or pay the cash at the cash counter of ITI at the time of reporting or by NEFT/ RTGS mode, details can be collected from the Training Centre. Students are also required to carry **three passport size photographs**. On reporting students will be issued with an identification badge permitting them to enter the factory premises during the period of training.

Working Hours/Holidays.

The working hours of the factory is between 8.00 AM and 4.00 PM and Sunday will be holiday. Besides, the National & Festival Holidays declared by the Plant would also be applicable.
