As a result, it was trading at Rs 103.05 on the NSE, up 6.07 percent with strong volumes, at the time of writing this article.

The stock rebounded sharply after three-day of downtick, and traded with biggest single-day gains since November 2022.

It traded above all near-term key moving averages (5, 9 and 21-day EMA - exponential moving average - Rs 99.75, Rs 99.60 and Rs 100.52), but seems to be finding difficult to

stay over the short term moving average (50-day EMA - Rs 102.96), though momentum indicator RSI (relative strength index 14) rebounded sharply from around oversold zone to over 50 level (at 56) indicating strength in the counter.




